

Horseshoe Falls Regional Council: Grace Representative

The Horseshoe Falls Regional Council held its Spring 2022 Hybrid Meeting on May 26-28, 2022, and a Fall Gathering on Oct. 14-15, 2022. The meetings were conducted online via Zoom with an option to attend in person or participate online via Zoom on May 28, 2022. There were approximately 110 total participants in attendance each day.

Each day began with President Robert Lawson welcoming everyone, the Land Acknowledgement was read followed by an opening prayer.

Throughout the meetings a variety of worships and presentations were made. Some topics included Antibullying, Our Words Matter: Reconsidering the Word "Mission" and a Korean Peace Appeal. The regional council elected Lennox Scarlett as President Elect who will be installed at the 2023 Spring Regional Meeting as president.

A video presentation was shown recognizing remembering regional council members who had passed away since the last meeting, community of faiths who have made life cycle changes, and recognized anniversaries of ministry personnel which included Rev. Kathryn Vance and Rev. Sheena Marini for 15 years of ordination.

Licensed Lay Worship Leaders were introduced including Heather King from Woodhouse United Church.

Horseshoe Falls Regional Council: Woodhouse Representative

The Horseshoe Falls Regional Council replaced the former Hamilton Conference, and the Halton, Erie, Hamilton and Niagara Presbyteries effective January 1, 2019.

Change of this magnitude presents many growing pains. The COVID 19 Pandemic brought additional issues to the transition. Meetings have been held online which creates technical challenges for many delegates. Dedicated representatives and clergy expressed their feelings of grief at the loss of regular monthly meetings that were held by the smaller Presbyteries.

It is my humble opinion that the formation of Horseshoe Falls Regional Council took a big step forward in 2022 when they were able to meet in person at the annual Spring Meeting – May 26-28 in Fonthill, ON. This event was a combination of delegates joining a Zoom meeting on Thursday and Friday, with the option for members to meet in person or, continue online on Saturday May 28. I was able to attend in person.

The Annual Spring Meeting dealt with many business issues such as reviewing and accepting budgets, listening to reports from various committees, electing a new Executive and Commission Members and celebrating milestones. Rev. Kathryn Vance and Rev. Sheena Riley-Marini were recognized for 15 years of service.

One of the sessions that attracted much discussion and was very thought provoking was on the topic of the word "Missions". Guest speakers who represent a variety of ethnic and cultural groups shared how the word mission has a very negative connotation. Delegates were challenged to share their thoughts and words that may be used instead of mission.

The following Word Cloud was developed from the discussion.



On Saturday afternoon, the Licensed Lay Worship Leaders (LLWL) for Horseshoe Falls Region were introduced and a Covenanting Service was held. This was the first time since 2018 that such a ceremony took place. I was very happy to be a part of the proceedings and received a license for three years.

As part of the Horseshoe Falls Regional Council, I have been serving on the LLWL Committee for the past year. It is our responsibility to interview each candidate and ensure that they have completed their educational courses, mandatory training and police checks. Candidates are then recommended to the Human Resources Committee for a one or three year license.

Our committee also plans a fall training day for the LLWL's. This year it was held at Five Oaks in September. A variety of guest speakers and workshops on how to prepare a Sunday Service, using the lectionary, and learning new music from More Voices were offered.

Horseshoe Falls Regional Council sends a newsletter each month that includes information about clergy, member churches, courses, events and updates from the various committees and projects. All members of our church are welcome to sign up for the newsletter. Please contact me if you would like to be included.

In late 2022 we updated our Violence and Harassment Policy following the United Church Of Canada Policy and government regulations. The policy is posted in both churches.

At the end of 2022, Carol Brightman joined the M&P Committee. Welcome to the team Carol.

I would like to thank the members of the M&P Committee for all your hard work in 2022. I would like to thank all the volunteers who work in the church office, and on our committees, your efforts certainly make our churches stronger and brighter.

As reported in the pastoral charge financial report, there were no capital expenditures as budgeted and there were no extraordinary operating expenses.

Mission and Outreach Committee

Thanks so much to our hard-working committee of Bev Hodgson, Maureen Clements, Steve and Carol Brightman, Lynda Simpson and Bill Drayer!

Early in the year we donated \$1,000 to H-N REACH and Youth in Transition to help children transitioning out of foster care. Though the TLC fund we were able to help a family after a house fire left them needing everything. We provided \$600 to the Norfolk Refugee Committee to help support the most recent Syrian family, \$300 for Caribbean Workers Outreach, \$300 for Canadian Foodgrains Bank. We also provided \$500 to help Sea Scouts needing assistance with fees and also for Sea Scout programming from our TLC fund. At year end we were able to support the Port Dover Lifeline Food Bank with \$200, the Six Nations foodbank with \$500 and also we again supported Nations United programing in Ohsweken with \$300 to support their reconciliation work.

For the Sock it to me program in October - we donated 412 pairs of socks, 22 hats, 9 gloves, 10 scarves and 4 pairs of long underwear to the Court Services program to provide some comfort to the mainly homeless population.

Also this year we have had a number of large fundraising drives. We raised \$2,300 for the Red Cross for humanitarian support in Ukraine, we raised \$650 for the Port Dover Lifeline Food Bank, \$4,500 for the Lakewood Christmas program and \$5000 to help the local Karida Family purchase a vehicle – they arrived late in the year from a harrowing journey from war torn Mariupol; we supported this with \$1,000 from our TLC fund, \$1,000 from a private donation and \$2,000 from the Rotary Club of Norfolk Sunrise, and \$1,000 from Rotary Club of Simcoe.

We were able to send \$ 22,600 to the United Church of Canada , with the help of the UCWs which provided \$750.

We are so thankful to all of the support from the congregations this year!

I heard an interesting observation from John Dominic Crossan which has been speaking to me: Society (as in the Roman Emperors in 1 CE) sought peace through violence, whereas Christ sought peace through justice. Think about it – how much of our conflict today could be solved by true justice for those living in poverty, the disenfranchised, First Nations etc?

Pastoral Charge Financial Committee

Current Financial Position:

Pastoral Charge Bank Balance as at December 31 is \$28,132. This includes the UCC Dues Fund balance of \$5,965, the Manse Capital Fund balance of \$7,190 and the Live Stream Fund balance of \$825. The \$40,000 CEBA government loan that we received during Covid was paid back during the year. HST Receivable \$668 as at December 31. Visa Payable \$491 as at December 31. As of December 31, we have a YTD deficit of \$5,186.

Variances in Budget vs. Actual:

- Relief Minister costs incurred \$4,032 that were not in the budget.
- Pastoral Charge Board approved up to \$1,000 in costs for the Church directory that were not in the budget. YTD expenses \$815.
- Minister travel and education budget of \$4893 was not used because of Rev. Kathryn's illness and recovery time off.

Actions Taken:

• PC Finance committee met in October to set the 2023 budget and to review the 2022 financial position. There was an estimated surplus of \$3,500 for 2022.

Recommendations from the PC Finance Committee and approved by the Board:

- To approve the 2023 Budget set by the committee with the understanding that there will be variances due to the search and appointment of a new minister.
- To waive the December payments from Grace and Woodhouse totalling \$8,576. This would result in a deficit of approximately \$5,000 which was reflective of the unbudgeted costs for relief pulpit supply and the church directory. It was the committee's position that it was the responsibility of the pastoral charge to cover this shortfall.





Finance Committee

I am pleased to report that Grace achieved a surplus of \$10,239 in 2022 compared with a surplus of \$12,258 in 2021. The slightly decreased surplus was due to higher expenses more than offsetting higher revenues following the resumption of services in January 2022.



Overall revenues in 2022 (excluding M&O) were \$20,377 higher than in 2021 with an increase in givings of \$10,901 reflecting the resumption of services and some one-time donations. Building use in other revenue was up \$7,187 as various users were able to resume their meetings.



Total expenses (excluding M&O) in 2022 were \$22,395 higher than in 2021. Pastoral charges increased by \$11,506 as the government Covid support programs wound down. Because some of the surplus in 2022 was in the nature of a "windfall", it was decided to contribute \$5,000 to Pastoral Care programs through M&O. Utilities costs increased by \$3,169 in 2022, mainly due to higher natural gas prices and Buildings and ground costs were up by \$2,946.

Church operations show a cash surplus of \$87,998 at the end of 2022 compared with a cash surplus of \$76,030 at the end of 2021.

On December 31, 2022, we were holding \$84,409 in capital funds. There were no major items of capital spending during the year.

2023 Budget

Our budget for 2023 indicates a deficit of \$1,447 compared with our surplus of \$10,239 in 2022. The 2023 deficit represents an expected reduction in givings from 2022 levels which included some one-time donations. This would be the first deficit at Grace since 2013.

We would like to thank our Envelope Treasurer Marilyn Dixon for her work on the PAR program and for acting as counter during the year. We recommend the PAR program to all members of the congregation.

Also, sincere thanks go to Marilynn Bobyk, Marilyn Dixon and Jim Simpson as members of the Finance Committee for their assistance and support during 2022.

- General Offerings/Donations are expected to decline from the 2022 levels which included some one-time donations.
- Use of building revenues are also expected to decline from 2022 levels which included revenues of \$850 from the Municipal elections.

Spending (excluding M&O) – up \$2,085.

- Pastoral Charges expenses assumes a return to normal levels following the end of the wage subsidy programs that were received in 2022.
- 2022 included a contribution of \$5,000 to Pastoral Care that is not expected to occur in 2023.
- Other cost increases are mainly inflation.

Woodhouse Trustees

The first of the year, we had not yet completed Sunday School and Kitchen renovations. George Bannister helped secure the new double cabinet holding the weight of the tea and coffee cups in the kitchen area. We found there is a lot of weight and if they fell over, it would be a disaster. New Countertops were custom fit and installed along with backsplash. Completed!

In March the Woodhouse Board approved a 2,000. budget to build an outdoor shed used mainly to store sidewalk de ice material, tables, electrical cords, small tools, shovels, to be much easier to set up for outdoor services including Decoration Day in August. -And to not store things in Sunday School room!

George Bannister and I took this project on. We were disappointed when two quotes came in at 5,000. and 7,000. 2 by 4's went from 4.00/a piece to ten dollars. It was no small challenge, we drove together and found a Mennonite with a saw mill and milled everything. The concrete pad alone was 600. and another quote was 1,000. George and I donated the labour, a friend Bruce Dale helped with roof pitch, aluminum soffit and facia. We had two old fashioned windows built and steel roof on the top. We were over budget but some donations came in to cover most of extra costs. Some stain to match coming in 2023. The Cemetery had planted 7 new trees at the back and along with Kathryn Bannister we would drag 600 feet of hose out back and water every 2nd and 3rd day July through September. A very dry summer! Turned into a lot of work! In 2023 we have plans to repair our stain glass windows in the church and then complete stained glass in Sunday School room after that. These windows were originally made, and paid for with donations by congregation members and completed in 1999. A plaque was erected with names of donors. The Walnut wood for the backing was donated by Doug Gundry from his family farm. Many members have come back and had their picture taken beside the plaque.

Problem was the stained glass were built without proper supports, too long of lead bars and the leading and putty came loose...I'm not finding fault, and then the storms we covered them with did not allow proper ventilation to allow air flow between the two sets of windows, therefore heat was trapped making stain glass panes easy to flex in and out like a hinge, weakening the strength of the windows.

I will be making a brief presentation at our Annual Meeting March 19th to explain as this is a big project. We found: Adam Frazee of Ridgetown to do the stain glass repair and Sunrise Stained Glass out of London to do the storms. Both have extensive experience and have worked well together. We will be asking for donations/fundraising etc as this is a big project.

We have some bricks which require repointing at front of the church, Front main door and trim around it require painting. Painting also required at back of church, second story windows.

Overall, we can be proud of the work we have completed and kept up on maintenance throughout 223 years!
